

## Team Defence Information

### 2026 Conference Delegate Terms & Conditions

#### 1. Registration

- 1.1. Registration for Team Defence Information Conferences subject to availability and approval by the conference organisers.
- 1.2. Delegates must provide accurate and complete information during the registration process.
- 1.3. Registration fees must be paid in full before attending the conference. Delegates are responsible for all associated payment processing fees.

#### 2. Cancellation and Refunds

2.1. Delegates may cancel their registration by providing written notice to the conference organisers. The refund policy is as follows:

- Cancellations received [30 days] or more before the conference start date will receive a full refund, minus a processing fee.
- Cancellations received less than [7 days] before the conference start date will not be eligible for a refund.

2.2. Substitutions of delegates from the same organisation are allowed at any time, provided written notice is given to the conference organisers.

#### 3. Program Changes

3.1. The conference organisers reserve the right to make changes to the conference program, schedule, speakers, or venue if necessary. Delegates will be notified of any changes promptly.

#### 4. Conduct

4.1. Delegates are expected to conduct themselves in a professional and respectful manner during the conference. Any disruptive or inappropriate behaviour may result in removal from the conference without a refund.

#### 5. Photography and Recording

5.1. Photography and audio or video recording of conference sessions, speakers, and materials may be prohibited without explicit permission from the conference organisers.
